# **Master + in Banking and Finance**

### **PRESENTATION**

The Master+ program in Banking and Finance is a unique opportunity to follow a standard Master program combined with a specific training delivered by a well-established research center (LAPE) dedicated to banking studies.

Teaching staff are active scholars in Banking or financial risk practitioners. The program also hosts international visiting professors who are leading experts in their field.

The Master is a one-year program fully taught in English. Applicants must provide satisfactory evidence that they have an adequate knowledge and understanding of written and spoken English.

#### **ENTRY REQUIREMENTS APPLICATION PACKAGE**

We welcome applications from good graduates in relevant disciplines (Economics, Business Administration, etc.). Applicants with a different academic background (Engineering, Mathematics, etc.) will be required to provide additional material regarding their background.
